<u>Terms and Conditions – Mascot Competition</u>

The Competition

- 4. When submitting your entry, you must provide your name, age and address, as well as the name/email address of your parent or guardian. Please also include the name of your nursery/school/youth group (if applicable). Any entries that do not include this information will not be judged. We will only use this information in relation to the competition (including checking your eligibility to enter it) and will not use it for any other purposes. We will not keep this information for longer than is necessary for the operation of the competition.
- 5. The competition will run until 5pm on 24th September 2021. The winner will be notified by 1st October 2021 and the winner must respond within **5 working** days. Scotmid and CHAS reserve the right to offer the prize to another entrant if the winner does not respond within this time.
- 6. The winner will be decided by a panel of independent judges on the basis of creativity, imagination and the entry that best represents the partnership between Scotmid and CHAS.

Eligibility
