The Directors of Scottish Midland Co-operative Society are pleased to present their interim report to members.

Overview

Scotmid continued to grow profit in the first 28 weeks of the financial year, despite the continuing recession. Operating Profit was marginally ahead at £4.6m, compared to £4.5m last year, but this masked a good underlying performance, bearing in mind the loss of profit from the sale of M&S Toiletries and significant additional supply costs absorbed by our Food Convenience business.

The Society's turnover for ongoing businesses grew to £183m, up £15m, driven by encouraging like for like growth in our retail businesses and resilient rental income from our properties. Scotmid's balance sheet remained strong with net assets of £94m.

Looking forward, the Society remains well placed to meet the challenges arising from the difficult economic conditions. We have taken the opportunity in the recession to continue to invest for the longer term development of our businesses. In particular, we have continued with our programme of food store refits and the ongoing expansion of the Semichem estate. New openings in the period included our first Semichems in North East England and further new openings are planned in the run up to Christmas.

Food Retail











Food Retail

The Food business has been able to drive profits forward despite absorbing significant increases in distribution and energy costs. The investment in new stores and the upgrades and refits over the last two years have benefitted the business.

The five refits completed during the first half of the year brings the number of stores trading in the new Scotmid format to 51. Additionally there are a further six stores which have had minor works carried

out, remerchandising and

graphics package giving the

stores a more modern feel.

Two new Scotmid convenience stores were opened in the last six months including the site of the former Woolworths in Stockbridge, Edinburgh.

The focus on availability continued. In particular, significant improvements have been achieved in the top 100 lines and across the range generally with the rollout of availability monitoring.

A significant amount of planning, administration, cost and training has resulted from the change in Scottish Alcohol Legislation which came into force on 1 September 2009. A sales impact in the second half is expected as a result of the implementation of this legislation.

Semichem







Semichem

Semichem continues to strengthen and grow its position in the marketplace as a leading discount retailer of branded health and beauty products. Once again good like-for-like sales growth, linked to a clearly defined range of branded products, gave Semichem a solid platform to move into the North East of England.

The first half of 2009 saw Semichem continue to roll out its long-term growth strategy, with new store openings in Wallsend, South Shields and Ashington in England and Omagh in Northern Ireland. A number of other stores were rebadged with our new branding.

The continued growth in sales across core and new stores can be attributed partially to a continued focus on growing profitable sales in core categories (such as household and fragrance)

while cementing Semichem's reputation as a destination for exceptional value. New ranges have also been added and extended in categories such as food and toys. Our stores in Northern Ireland have also continued to benefit from increased cross border trade as a result of the strong euro.

We look forward to Christmas with an exciting new media and TV campaign but remain concerned about the increase in VAT effective on 1 January 2010, both in timing and its potential impact on trading.

Following its launch at the end of 2008, the Semichem

website – www.semichem.co.uk extended its range from 500 to nearly a full store range of 2000 products. Since January, the site has also undergone major visual enhancements, improving focus and extending delivery range from the UK to all of Western Europe.



Property

The Division delivered a good performance against a background of difficult economic conditions. Both commercial and residential property markets continue to be challenging, although there are indications that the rate of decline in capital values is slowing. On the commercial side occupational demand is weak but we have benefitted from a low level of tenant bad debts, reflecting the defensive nature of our portfolio. On the residential side the strong occupancy rates have helped to maintain rental income, despite the increased supply of properties available to let in the market.

We have now completed the 20,000 sq ft office building adjacent to our Head Office in Newbridge and, even in a challenging office market, have secured our first tenant. In partnership with adjacent landowners we have lodged outline planning permission for a development on a site in Armadale, part of which contains an existing Scotmid supermarket.

Funeral

In common with other funeral directors generally, the Funeral Division experienced a small reduction in the number of funerals conducted in the first half of the year. However a focus on incremental services and cost control resulted in a trading performance in line with the first half of last year. The business made a number of investments to enhance our profile and service, including new style signage for both Fountainbridge and Angle Park Funeral Homes in Edinburgh and three new Mercedes vehicles.

Membership Development

Following two successful pilots we rolled out our new membership materials to all food stores which made our membership offering more visible and easier to access for our customers. The membership magazine Jigsaw continues to go from strength to strength. The fourth edition included the results from our membership survey and the most recent edition featured an attractive voucher offer which proved very popular with members.

The Society is currently in the process of reviewing its membership and democratic structure as part of a Constitutional review. The aim is to create a structure fit for the 21st century and so far we have covered areas including member democracy, member relations committees. communication and support. As part of the review we held a consultation meeting at which members had the opportunity to hear the constitutional review proposals, ask questions and feedback their views. This feedback was then used to help shape the final Constitutional review proposals that were approved at a Special Members meeting in September.

Community & Charitable Activities

I50th Anniversary

This has been an exciting year for the Society as we celebrate our 150th anniversary. Celebrations have been held throughout the year involving staff, members and customers. From an opening Church service at St Cuthbert's in Edinburgh through to special offers for customers, a raft of charity events, the production of a special DVD and brochure, we have helped ensure that the 150th is well recognised. The DVD will be launched at the OGM.

General Community

We continue to work closely with our communities (especially at store level) to provide support for a diversity of groups and ages. Our two "smoothie bikes" have been a major success in schools, gala days, charity events and conferences - this unique form of making smoothies has been well received. Other community initiatives have included continued support of the "Booze you Looze" project in East Calder; Street Football (where we worked with the Police and local community on a football initiative to give youngsters a new focus) and a Youth Disco in Fraserburgh where, through our support, youngsters under 18 were able to attend 'early doors' alcohol free discos.

Fairtrade

In February we sponsored the Lord Provost's reception in Edinburgh City Chambers featuring a wine tasting by renowned wine expert Rose Murray Brown. We have also been at the forefront of many Fairtrade events throughout Scotland – we have helped schools attain Fairtrade status and worked closely with the Scottish Fairtrade Forum at a number of events.

Charity

As part of our ongoing community activity and the 150th anniversary celebrations we have been working with five charities throughout the year instead of just one. The charities are Cystic Fibrosis, Alzheimer's, Leukaemia Research, Cash for Kids and CLIC Sargent. From collecting cans in our stores through to sponsored walks and runs and sponsorship of Pedal for Scotland, we have already been able to make a significant contribution to these charities.

Appreciation

The Directors would like to thank our members, customers and staff for their support over the last six months, as the business continues to build its financial and democratic strength.
